

COUNCIL HIGHLIGHTS

Monday, January 19, 2026

City Manager's Office

1. Council entered into a one-year Seamless Levy Agreement for the 2026 calendar year with Lloydminster Public School Division (LPSD) and Lloydminster Roman Catholic School Division #89 (LRCSD) and that the Mayor and City Manager be authorized to sign and seal all necessary documents.

Community Development Services

1. Council awarded the contract for the servicing and maintenance of the two Cenovus Energy Hub elevators to Kone Inc. of Winnipeg, MB for \$9,960, excluding GST, for a 10-year term. In addition, that Administration be authorized to sign and seal all necessary documents.
2. Council approved the appointment of Ronda Zinger to the Social Policy Framework Leadership Team for a six-month term commencing January 19, 2026, and ending July 01, 2026.
3. Council dissolved the Friends of Cenovus Energy Hub (formerly Friends of Lloydminster Place) Committee.
4. Council approved the appointment of Colleen Hoegl, Otis Rusling and Gwen Mottram to the Public Art Advisory Committee for a term ending December 31, 2027.

Operations

1. Council approved the City of Lloydminster enter into an amending Raw Water Supply Agreement with Cenovus Energy Inc. In addition, that the Mayor and City Manager be authorized to sign and seal all necessary documents.
