

BYLAW NO. 01-2022

A BYLAW OF THE CITY OF LLOYDMINSTER IN THE PROVINCES OF ALBERTA AND SASKATCHEWAN TO AMEND A SUITE OF CITY OF LLOYDMINSTER BYLAWS TO INCORPORATE THE ANNEXATION AREA.

WHEREAS the Council of the City of Lloydminster deems it necessary to establish a Bylaw to deal with the peace, order and good government of the City.

AND WHEREAS the *Lloydminster Charter* provides authority to City Council to pass bylaws for municipal purposes;

AND WHEREAS the *Lloydminster Charter* provides authority to the City to pass bylaws respecting the enforcement of bylaws.

NOW THEREFORE the Council of the City of Lloydminster deems it necessary to establish a Bylaw to incorporate the Annexation Area; and

NOW THEREFORE, the Council of the City of Lloydminster, pursuant to the authority granted in Section 15 of the *Lloydminster Charter*, enacts as follows:

1. SHORT TITLE

1.1. This Bylaw shall be cited as the Annexation Bylaw.

2. BYLAW AMENDED

2.1. The Community Standards Bylaw No. 10-2018 is hereby amended in the following manner:

- Add the following:
 - 4.3. Urban Transition lands, as defined by the Land Use Bylaw, shall be exempt from Section 4.2 (a) – Section (h).

2.2. The Traffic Bylaw No. 05-2021 is hereby amended in the following manner:

- Add the following;
 - 5.22.1. Notwithstandaing the above, Off-Highway Vehicle or Snowmobiles may be permitted in the Annexation Area outlined in Schedule "A" of the Annexation Bylaw No. 01-2022, if licensed and operated per provincial regulations and requirements.

2.3. The Stormwater Utility Bylaw No. 09-2017 is hereby amended in the following manner:

- Add the following;
 - 4.11. Lands identified in Schedule "A" of the Annexation Bylaw No. 01-2022 shall be exempt from the Stormwater Utility rates.

- 2.4. The Utility Bylaw No. 26-2016 is hereby amended in the following manner:
- Subsection 36(c) is removed and replaced with the following;
 - No Person shall drill or otherwise locate a new groundwater well within the City, unless subject to (e).
 - Add the following subsection under Section 36;
 - (e) Any existing groundwater wells currently used for domestic use located in the Annexation Area outlined in Schedule "A" of the Annexation Bylaw No. 01-2022 shall remain in use unless subject to (b).

This Bylaw shall come into force and effect upon the final passing thereof.
