Lloydminster, Alberta/Saskatchewan, do hereby authorize all police officers of the Royal Canadian Mounted Police ("RCMP") and all Community Peace Officers of the City of Lloydminster ("CPO") to act as my agent/occupier* pursuant to the *Trespass to Premises Act (AB)*, *Petty Trespass Act (AB)* and the *Trespass to Property Act (SK)*. As my authorized representative, any police officer or community peace officer may issue and enforce bans against any person who, in their sole discretion, is determined to be a trespasser on the property, and to affect their purpose, are further authorized to enter onto any portion of the above noted property*.

In order to assist the RCMP and CPO's with identifying the location as one which has designated Agent Status to the RCMP and CPO's, the RCMP and CPO's will provide a sticker that I will display in a place open to public view.

The authorization to ban or enforce bans is in effect 24 hours/day. This authorization is intended to remain in effect until revoked in writing, at which time the sticker should be removed and returned to the RCMP. If the existing owner/representative of the business/property listed upon this document is leaving the business/property as the owner/representative, they must notify the RCMP of such, thus terminating this agreement.

Appendix A

By registering for the AGENT program, I understand and agree to the following:

1. *For the purposes of enforcement in the Province of Saskatchewan, the RCMP and CPO's will act as the "occupier", pursuant to section 2(c)(ii)(b) of the *Trespass to Property Act* (SK)- "has control over persons allowed to enter in or on the premises"
2. If the existing owner/property representative of the property listed upon the document is leaving the business/non-profit or property as the owner/representative, they must notify the Lloydminster RCMP of such change.
3. I understand that myself, and my business, will still be required to call should there be a concern, and by signing up for the program, it does not mean proactive patrols will be conducted.
4. The supplied agent sticker must remain posted, and clearly visible while participating in the program. Should I terminate my businesses involvement in the Agent program, I will remove the sticker and return it to the Lloydminster RCMP Detachment.
5. Known people that have trespassed will not be permitted to be on the property.
6. If a trespass notice has been issued to an individual, you may request a review of the notice and timeline to the below contact. A request must be submitted in writing, and explain the reasoning's for the review and why you do not agree with the notice, or the timeline issued. After a review is completed, Administration of the program may confirm, vary, or cancel the notice, and the decision is final.
7. All notices of Trespass shall be deemed to be **indefinite**, unless otherwise requested by the representative named on the attached application form.
